**4. First-aid measures**

First-Aid measures

- Inhalation** : If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention immediately.
- Ingestion** : If swallowed, do not induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Loosen tight clothing such as a collar, tie, belt or waistband. Get medical attention immediately.
- Skin Contact** : In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Thoroughly clean shoes before reuse. Get medical attention immediately.
- Eye Contact** : Check for and remove any contact lenses. In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical attention immediately.

Effects and symptoms

- Ingestion** : May be fatal if swallowed. May cause burns to mouth, throat, and stomach.
- Skin Contact** : Extremely hazardous in case of skin contact (corrosive). The amount of tissue damage depends on length of contact. Skin contact can produce inflammation and blistering. Skin contact may produce burns.
- Eye Contact** : Extremely hazardous in case of eye contact (corrosive). Eye contact can result in corneal damage or blindness.
- Aggravating conditions** : Repeated exposure of the eyes to a low level of dust can produce eye irritation. Repeated skin exposure can produce local skin destruction, or dermatitis. ## 5. Fire-fighting measures

## 6. Accidental release measures

## 7. Handling and storage

- Handling** : Keep locked up. Keep container dry. Keep away from heat. Keep away from sources of ignition. Empty containers pose a fire risk, evaporate the residue under a fume hood. Ground all equipment containing material. Do not ingest. Do not breathe dust. Never add water to this product. If ingested, seek medical advice immediately and show the container or the label. Avoid contact with skin and eyes. Keep away from incompatibles such as oxidizing agents, acids, alkalis.
- Storage** : Keep container tightly closed. Keep container in a cool, well-ventilated area. Do not store above 20°C (68°F).
