4. First-aid measures

First-Aid measures

Inhalation : If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.

5. Fire-fighting measures

- Flammability of the Product** : May be combustible at high temperature.

6. Accidental release measures

7. Handling and storage

Do not ingest. Do not breathe dust. Wear suitable protective clothing. In case of insufficient ventilation, wear suitable respiratory equipment.
